**RE: Administrative Modification and Amendment to the Fiscal Year 2009-2012  
Statewide Transportation Improvement Program (STIP)**

Dear Ms. Klekar:

Pursuant to the jointly adopted Administrative Modification procedures, the Nevada Department of Transportation intends to make the following changes:

Federal Lands Highways – Statewide 8

- Forest Highway 1 (SR28) 4R – Grading, drainage, erosion control / move \$3,000,000 from FY 2010 to FY 2012
- WA200202 – SR28 from the Mt. Rose Highway (SR431) to the CA/NV Stateline / Erosion Control, Water Quality Improvements (PE, Const.) / Move \$3,000,000 from FY2011 to FY 2010 and add \$1,100,000 to FY 2009

Tahoe Bond/Assembly Bill 285 – Tahoe 1

- WA200202 – SR28 from the Mt. Rose Highway (SR431) to the CA/NV Stateline / Erosion Control, Water Quality Improvements (PE, Const.) / Move \$4,100,000 from FY 2011 to FY 2010 and decrease to \$4,000,000

Pursuant to the jointly adopted Amendment procedures, the Nevada Department of Transportation (NDOT) intends to make the following changes to the FY 2009-2012 Statewide Transportation Improvement Program (STIP):

Federal Lands Highways – Statewide 8

- WA200599 - SR431 Master Plan and Design Water Quality Improvements / Move \$2,500,000 from FY 2011 to FY 2009
- Nevada Stateline to Stateline Bicycle Facility (New Project) / Add \$100,000 in FY 2009, \$500,000 in FY 2010, and \$500,000 in FY 2011 for PE

Scenic Byways – Statewide 8

- Nevada Stateline to Stateline Bicycle Facility (New Project) / Add \$223,000 in FY 2010 for PE

Southern Nevada Public Lands Management Act (SNPLMA) – Statewide 24

- WA200599 – SR431 Master Plan and Design Water Quality Improvements / Move \$350,000 from FY 2011 to FY 2009 and reduce amount to \$35,000
- DO200424 - US50 Erosion Control and Water Quality Improvement Project / Add \$808,000 in FY 2010
- ✓ Nevada Stateline to Stateline Bicycle Facility (New Project) / Add \$160,000 for PE in FY 2009 and \$282,000 in FY 2010 for PE

Tahoe Bond/Assembly Bill 285 – Tahoe 1

- ✓ WA200599 – SR431 Master Plan and Design Water Quality Improvements / Add \$2,025,000 in FY 2011 and add \$7,000,000 in FY 2011

State Gas Tax – Tahoe 2


- ✓ DO200424 - US50 Erosion Control and Water Quality Improvement Project / Change fund source from Tahoe Bond to Gas Tax and move \$615,000 from FY 2010 to FY 2009
- ✓ Nevada Stateline to Stateline Bicycle Facility (New Project) / Add \$150,000 for RW from Nevada State Parks and Open Space Bond for FY 2010
- ✓ Nevada Stateline to Stateline Bicycle Facility (New Project) / Add \$1,100,000 for construction from the Nevada Division of State Lands for FY 2011

NDOT has reviewed the air quality conformity statement by the Tahoe MPO and concurs that these projects are exempt from an air quality analysis per 40 CFR 93.134 & 135.

NDOT intends to move forward with this administrative modification and this amendment as requested in the Tahoe MPO letters dated respectively June 3, and June 10, 2009. As of this date, these changes will not impact any other project in the STIP. As the Governor's designee I approve this amendment and request the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) also approve this amendment. Please incorporate this letter and the replacement pages in the adopted FY 2009-2012 STIP.
