Pursuant to the jointly adopted Administrative Modification procedures, the Nevada Department of Transportation (NDOT) intends to adjust. This action adds and amends several American Recovery Reinvestment Act (ARRA) projects in the FY 2010 – 2013 Statewide Transportation Improvement Program (STIP).

NDOT has received concurrence from the local agencies. As of this date, this change will not impact any other project in the STIP. NDOT has determined that this project is consistent with the FY 2009 – 2030 Regional Transportation Plan and is exempt from air quality analysis per 40 CFR 93.126, Operating assistance to transit agencies.
