Dear Mr. Aljabiry:

Please accept this **revised** Administrative Modification #5 to the Tahoe Metropolitan Planning Organizations (TMPO) 2008 Federal Transportation Improvement Program (FTIP). This Administrative Modification replaces the Administrative Modification #5 that was sent on June 3, 2009. The original administrative modification included the Kings Beach project TMPO ID TMC0203 request to remove from the project description "widen roadways" which has been deleted from this modification. The other projects remain as originally submitted. TMPO staff is requesting these changes for the attached projects using delegated authority by the TMPO Executive Director to process administrative modifications to the FTIP. Each modification falls in accordance with California's revised procedures for FTIP Amendments & Administrative Modifications as approved by the Federal Highway Administration on November 17, 2008 and are within the same four year FTIP period. The proposed changes are administrative in nature and will impact neither the regions air quality conformity nor the financial constraint of the FTIP.
