Please accept this approved administrative modification No.9 to the Tahoe Metropolitan Planning Organization (TMPO) 2011 Federal Transportation Improvement Program (FTIP). TMPO staff has modified the attached projects using delegated authority by the TMPO Executive Director to process administrative modifications to the FTIP/FSTIP.

The administrative modification modifies fund sources in two existing projects in the Grouped Projects for Bicycle and Pedestrian Facilities. Please see attachments for details.
